## **Vendor Application Information**

The Altamont Cruisers annual charity fundraiser, the **Nostalgia Day Car Show**, will be held on the city streets of downtown Livermore on **Sunday September 29, 2024**. We expect approximately 750 classic and custom cars. We appreciate your support in this important fundraiser that helps our local community.

- All of the proceeds from the show will go to local charities. Since this is a family oriented show, there can be no drug, adult, or profane words or pictures displayed.
- The vendor spaces average a generous 150 (10'x15') square feet and will rent for \$150.00 each for the one-day show. Any location preferences can be added to the application NOTES section, we will do our best to accommodate you. You need to provide your own canopy/ezup.
- Please note there will absolutely be **NO REFUNDS**.
- The hours of the car show are 9 AM to 4 PM. All setup must be completed with your vehicles off the car show streets before 8 AM. Tear down must wait until 4 PM and you must be vacated by 5 PM when the street barricades are removed.
- If you require electricity you will need a generator, and it must be located directly behind your booth.
- <u>If you are selling items:</u> You will need to have a City of Livermore business license. This is a requirement of the City of Livermore. You will need to call the City of Livermore (925-960-4310). Include a copy with your application.
- <u>If you are selling food:</u> Food vendors must have an Alameda County Health Temporary Food Booth (510-567-6717, see https://deh.acgov.org/operations/tff.page, or contact them by email at DEHTempevent@acgov.org). Include a copy with your application.
- We will have a raffle booth and any raffle gifts you can donate to us will be greatly appreciated and get you a little advertising.
